Service of alcoholic liquor shall be only during the time that the athletic, health or sports portions of the premises are open and available for use. Class B, class C, class D, class E, and the class F licensees shall be eligible to obtain a class L license at no charge. Class L licensees shall be subject to the following requirements:</p> <ol style="list-style-type: none"> The area of the licensed premises shall be no less than 200 square feet in size, clearly identified, and restricted to the persons aged 21 years or older ("the designated area"). Customers shall not remove open alcoholic beverages from the designated area of the premises. The designated area shall be open and the sale of beer and wine for consumption on the premises shall take place only during the hours permitted by the underlying liquor license. Alcoholic liquors in the original package may only be sold by a cashier outside the designated area, may not be purchased or sold in the designated area, and packaged liquors may not be consumed in the designated area. There shall be a paid attendant to monitor the designated area at all times. Food for consumption within the designated area must be available at all times. Retail sales may be for consumption on or off the licensed premises. Any sale of wine for off-premise consumption shall be in a sealed container. Any sale for on-premises consumption shall be no more than six (6) ounces to any individual when food is not served. Class A and class G licensees shall be eligible to obtain a class M license for the same premises at no charge. Nothing in the issuance of a class M license shall be considered to relieve the licensee of any responsibility for complying with all applicable state and federal regulations relating to the manufacture and/or sale of wine or other alcoholic beverages and with all applicable business and other regulations of the Village.</p>	\$1,850.00	\$1100.00

	<p>ounces of unopened beer per patron, or no more than 750 milliliters of unopened wine per two patrons, or no more than 750 milliliters of spirits per four patrons.</p> <p>b. When alcoholic liquor is available, no one under the age of 18 years may be on the premises, unless the event is held in a publicly owned facility. Further, the licensee must have a means of ensuring that persons under 21 years of age do not consume any alcoholic liquor.</p> <p>c. At the licensee's discretion, the licensee may require the alcoholic liquor to be opened and served by the licensee, and the licensee may charge a corkage or setup fee for that service.</p> <p>d. Patrons may only consume commercially manufactured alcoholic beverages as defined by 235 ILCS 5/1-3.01 through 3.04.</p> <p>e. A partially consumed bottle of wine or spirits or sealed beer bottles/cans that are to be removed from the premises shall be securely sealed by the licensee or an agent of the licensee prior to removal from the premises and placed in a transparent, one-time use, tamperproof bag.</p> <p>f. Any alcoholic liquor not consumed by the patron and not sealed in accordance with Section 6-43 (14) e. shall be destroyed by the licensee or its agents or employees.</p> <p>g. Class N licensees shall be liable for violations of this chapter in the same manner as the holder of any other classification of liquor license, including, but not limited to, violations for service to minors and the over serving of patrons.</p> <p>h. Class N licensees are prohibited from storing alcohol on the premises, unless the licensee also has an appropriate license allowing the retail sale of alcoholic liquors on the premises.</p> <p>i. Class N licensees must obtain dram shop and/or host liquor liability insurance coverage.</p> <p>j. At all times when alcoholic beverages are being consumed on the premises there shall be present at least one agent or employee of the licensee who is the holder of a valid training certificate issued by a trainer certified by the State of Illinois Liquor Control Commission consistent with Section 6-45 of Village Code.</p> <p>k.
